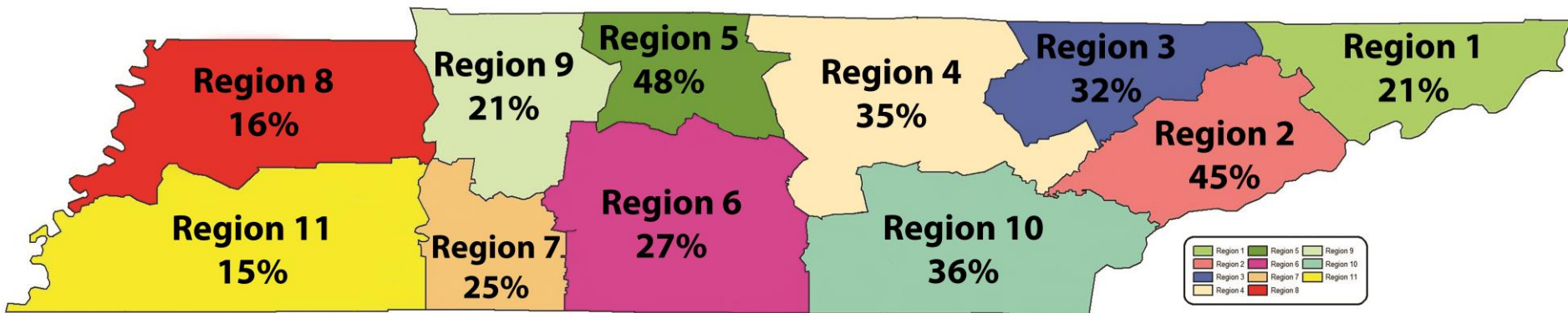

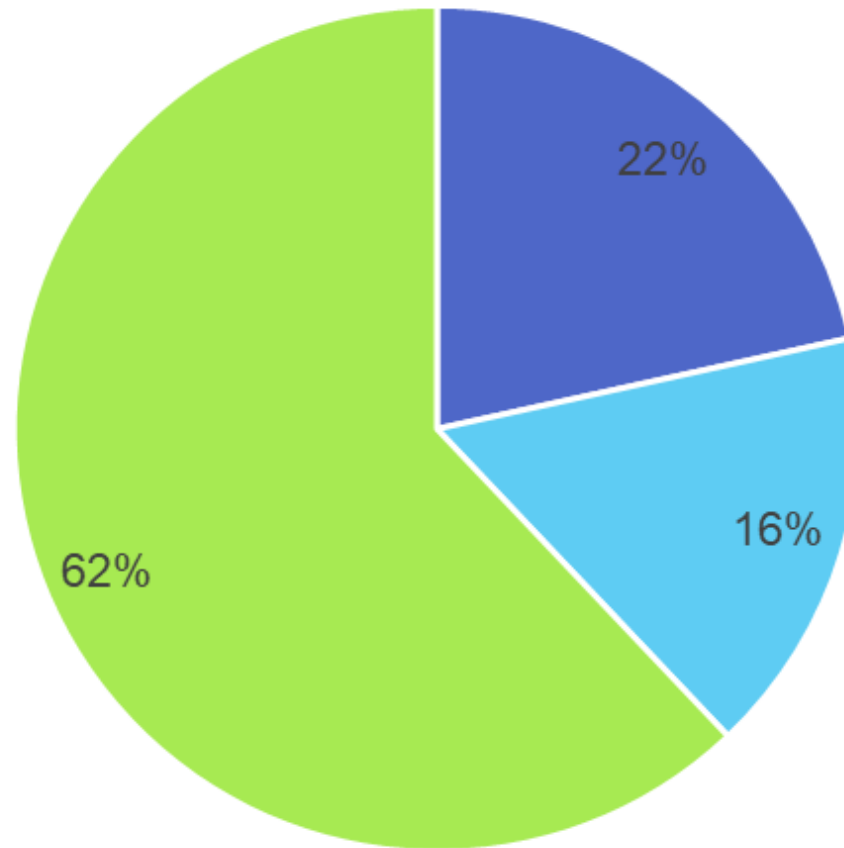

- 43 Municipalities – 20% participation

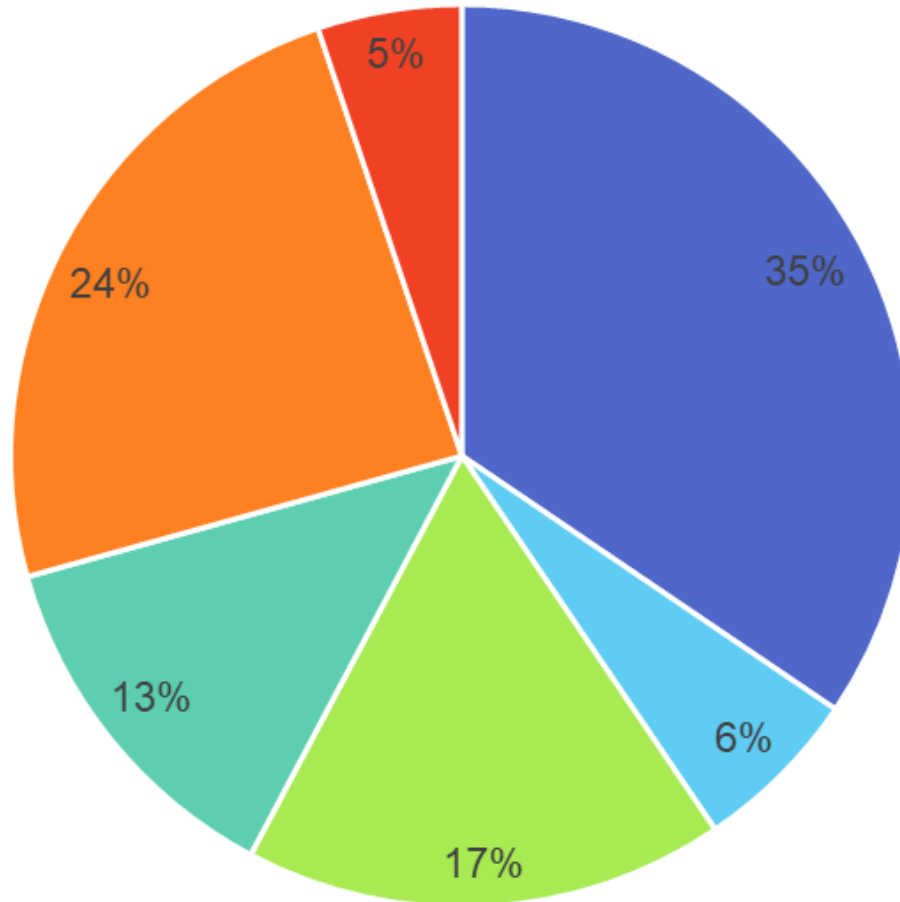


## Type of Rate



■ Declining Block Rate    ■ Increasing Block Rate    ■ Flat Rate

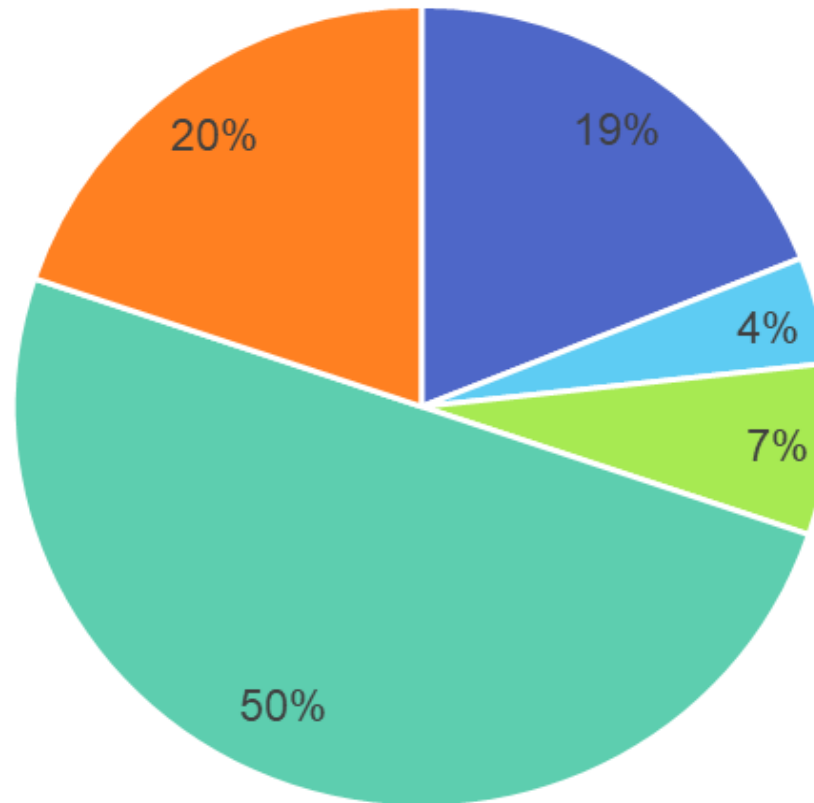
## Usage Included in Customer Charge

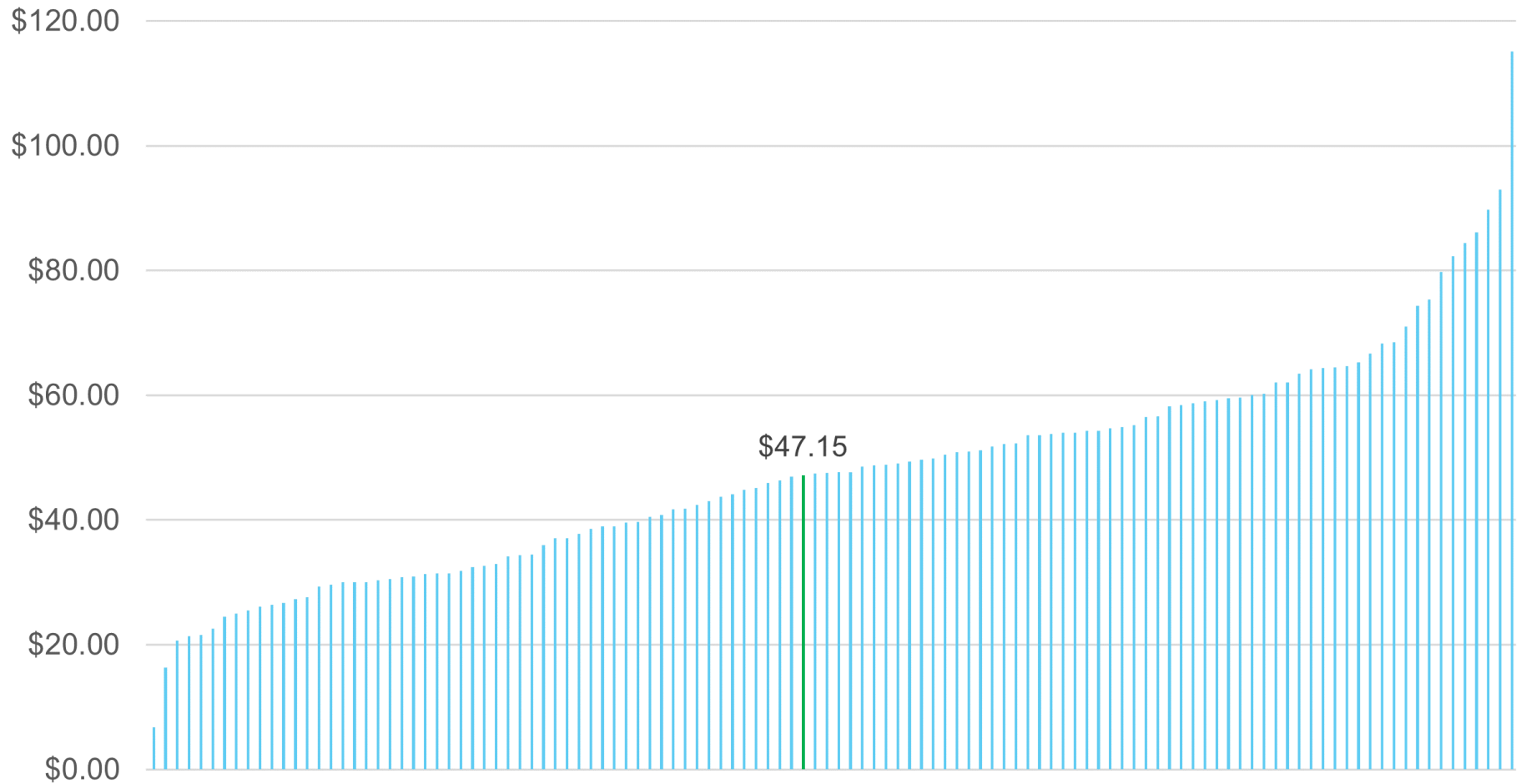

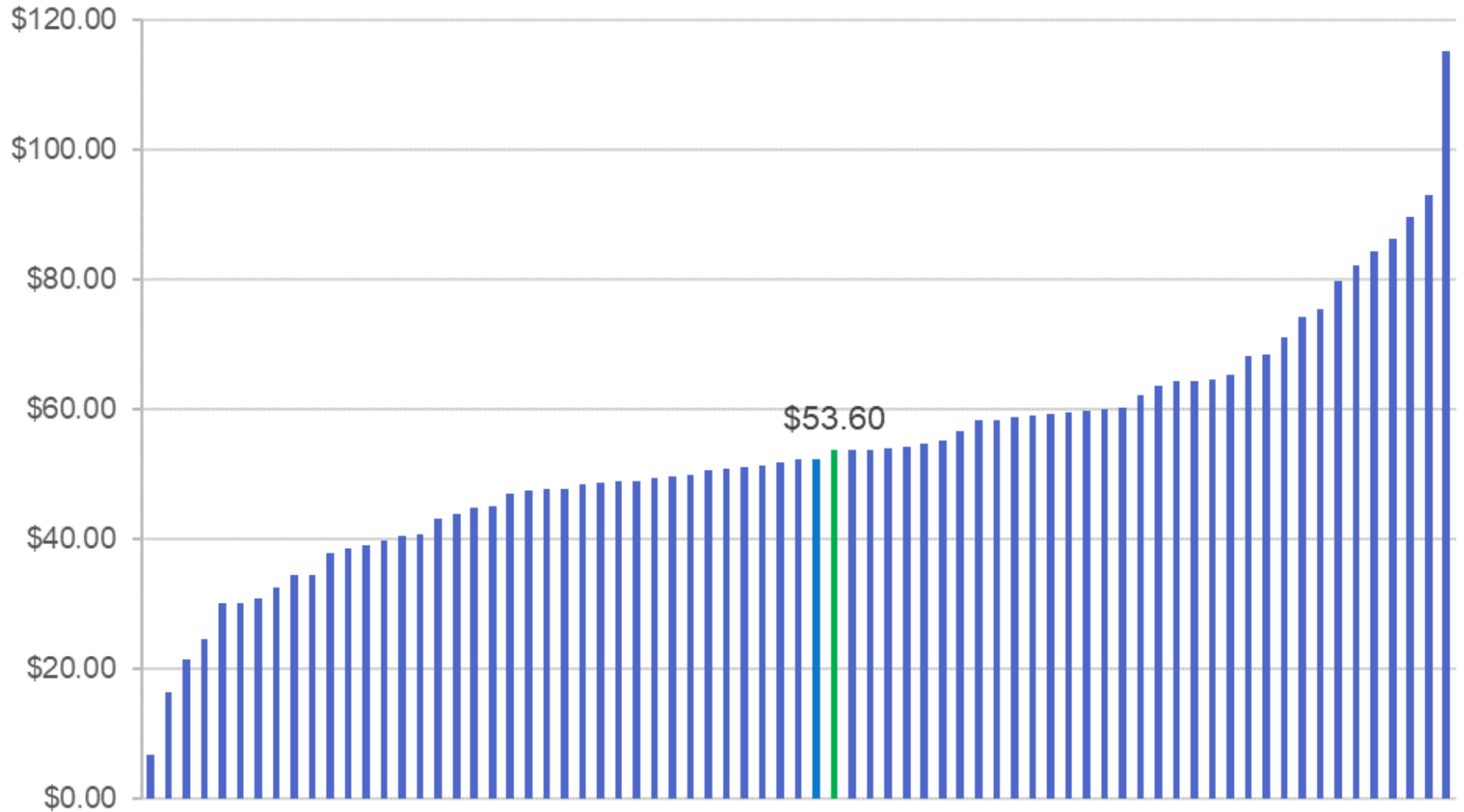

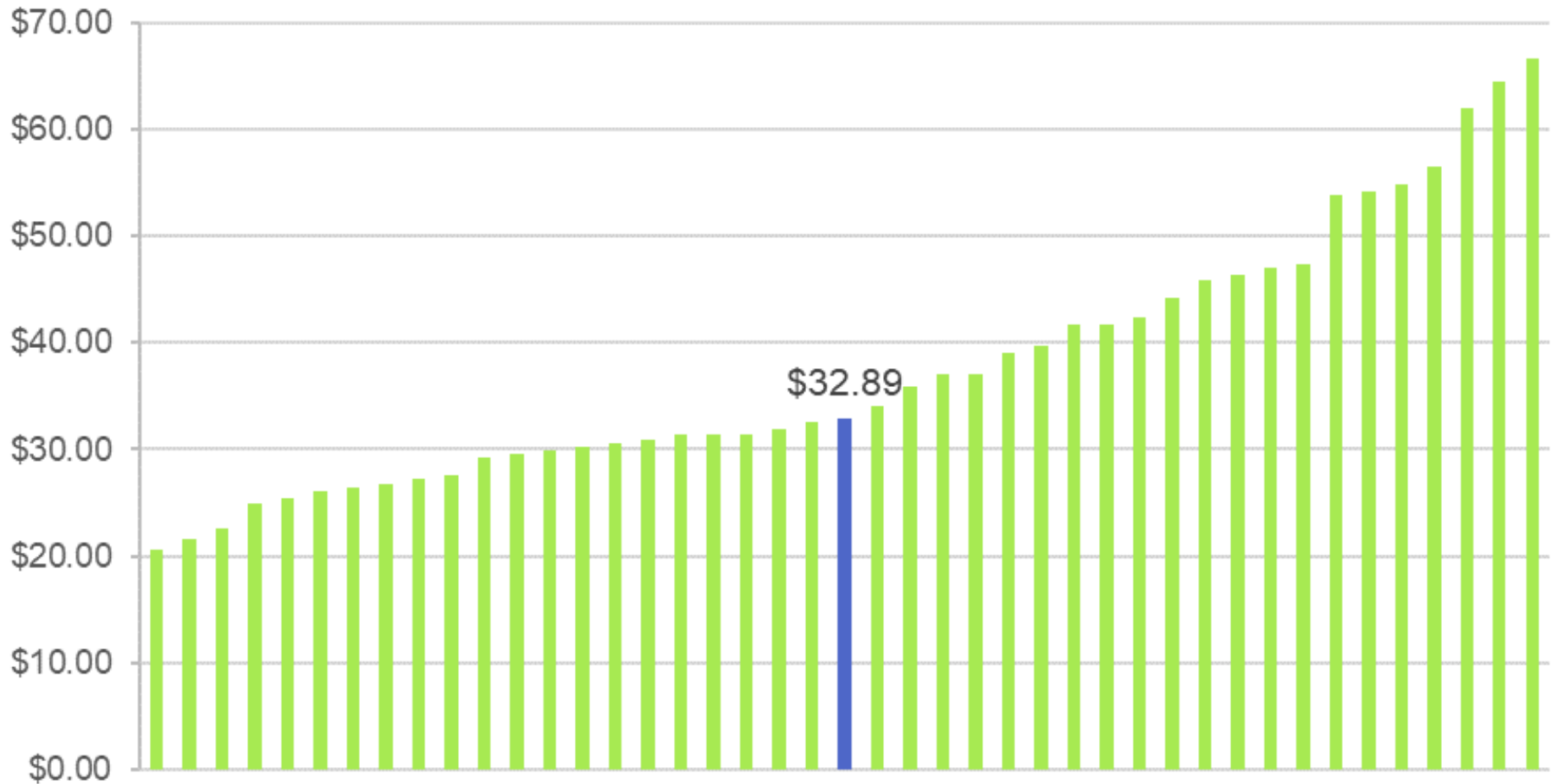
# Rate for 5,000 Gallons



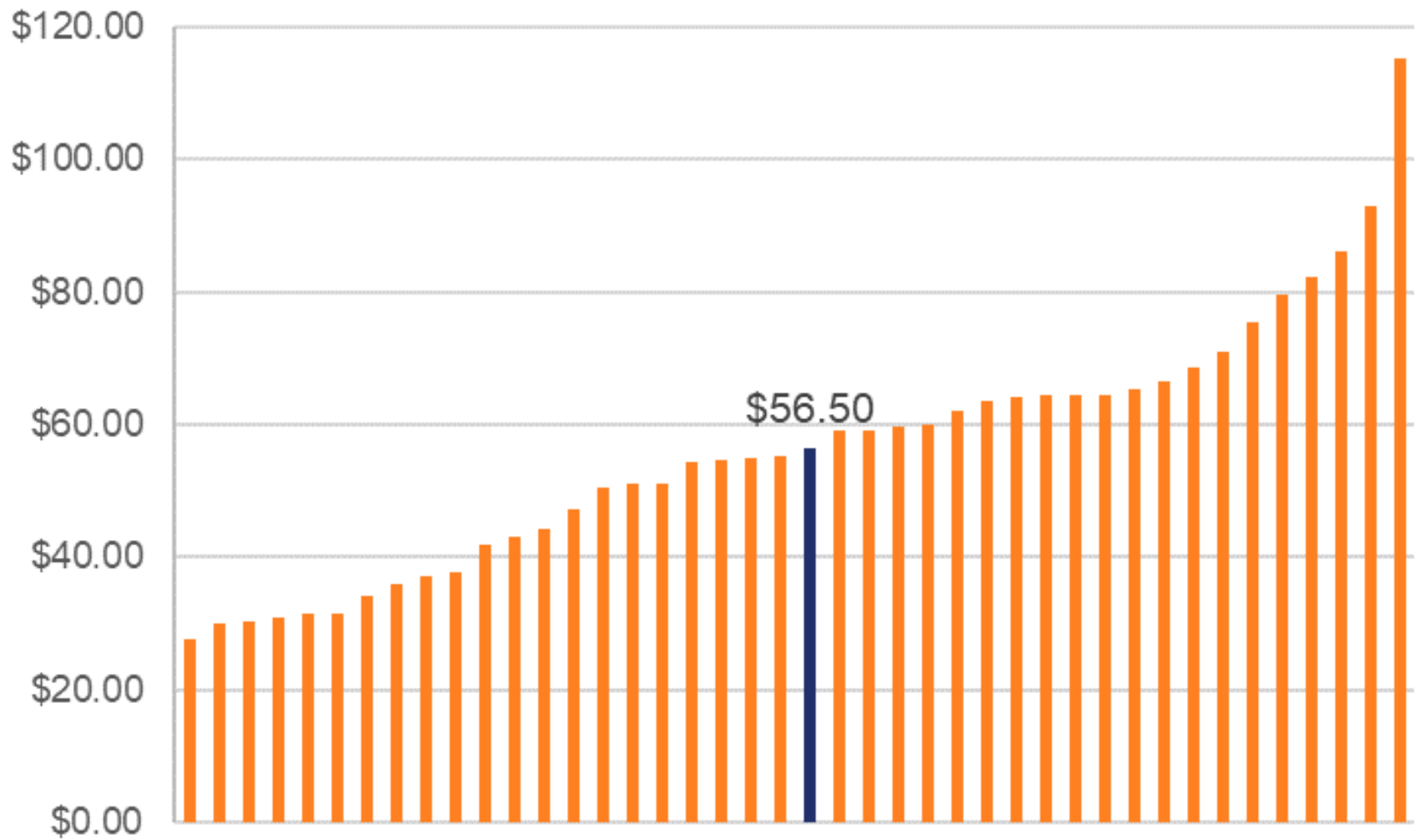
## Rate for 5,000 Gallons - Districts



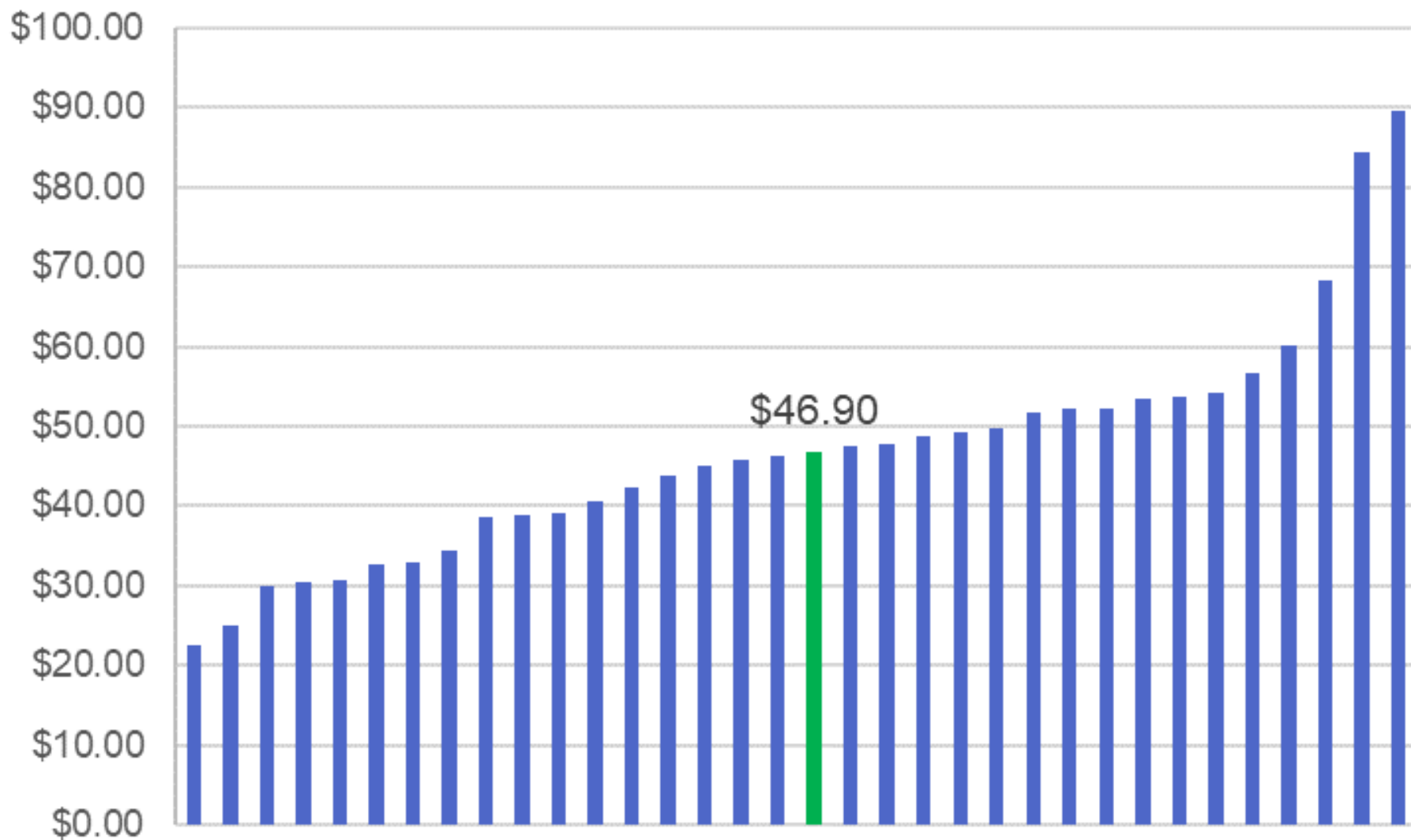
## Rate for 5,000 Gallons - Municipalities



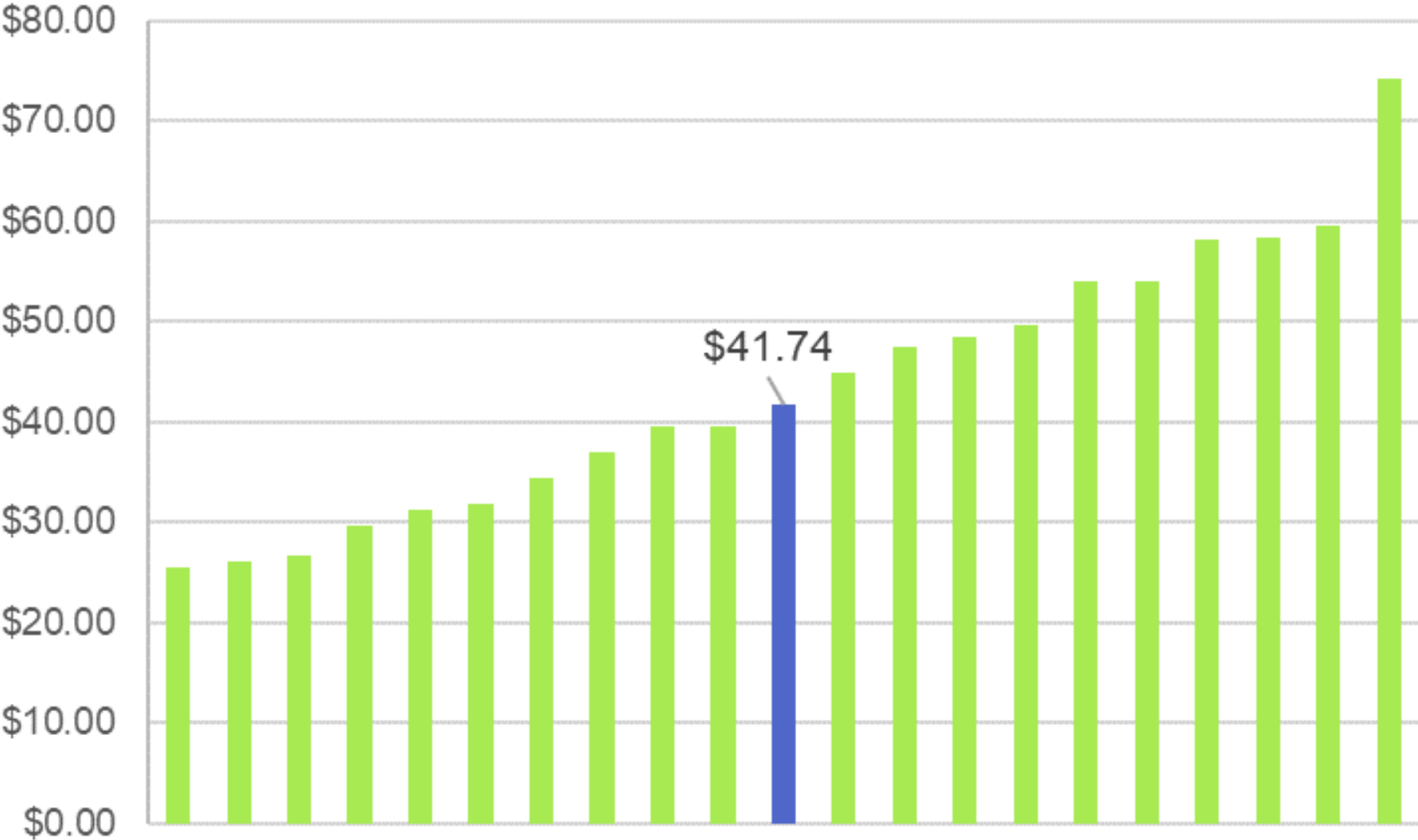
## Rate for 5,000 Gallons – Small Utility (Less than 2,900 meters)



## Rate for 5,000 Gallons – Medium Utility (2,900-6,999 meters)

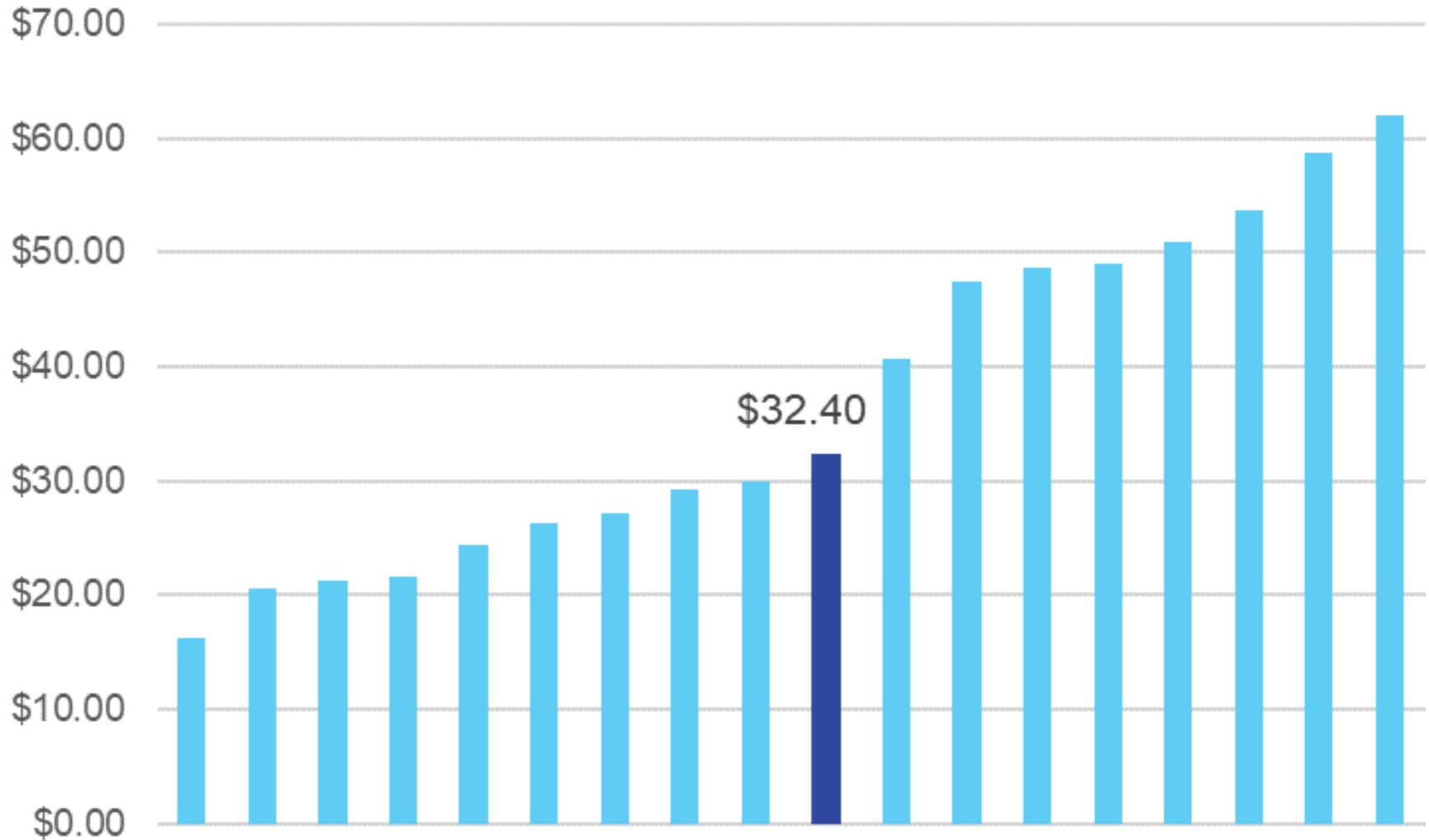


Rate for 5,000 Gallons – Large Utility (7,000-14,999 meters)

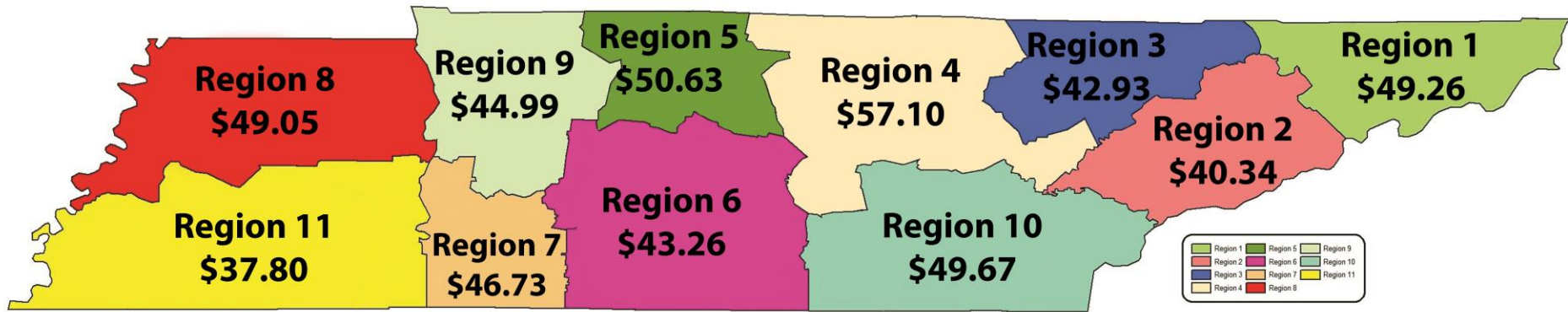




## Rate for 5,000 Gallons – Very Large Utility (at least 15,000 meters)
