**NEW COMMISSIONERS** must attend a minimum of twelve (12) hours of commissioner training and education within one year of the initial appointment or election to the board of commissioners.

**INCUMBENT COMMISSIONERS** in office must attend a minimum of twelve (12) hours of commissioner training and education prior to or within one year of re-appointment or re-election.

*Commissioners must attend a minimum of twelve (12) hours of commissioner training every three (3) years after completing their initial commissioner training.*
